

**Directions to the Hunt Test site,
Circle W Hunting Preserve, Heflin, Alabama**

Circle W is located one hour from Birmingham or Atlanta off I-20 at Exit 199 in Heflin, Alabama.

From Birmingham:

Take I-20 East toward Atlanta. Take Exit 199 and turn right. Take the first left onto New Harmony Church Rd. Follow until it dead ends and turn right. After the sweeping left curve in the road, Circle W will be about .2 miles on the left at the top of the hill. Look for the storage barn on the right across from the driveway to the clubhouse.

From Atlanta:

Take I-20 West toward Birmingham. Take Exit 199 and turn left. After crossing the bridge, take the first left onto New Harmony Church Rd. Follow until it dead ends and turn right. After the sweeping left curve in the road, Circle W will be about .2 miles on the left at the top of the hill. Look for the storage barn on the right across from the driveway to the clubhouse.

 Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
